VideoPodcasts.TV is committed to protecting your privacy when you use the VideoPodcasts.TV Service, which is comprised of (i) the VideoPodcasts.TV website, currently located at www.VideoPodcasts.TV (and/or any successor or additional website(s) owned or operated by or for VideoPodcasts.TV); (ii) the VideoPodcasts.TV syndication network (which may include third party websites); (iv) the servers operated by or on behalf of VideoPodcasts.TV; and/or (v) any other technology and/or services that VideoPodcasts.TV provides its users. The following Privacy Policy was prepared to inform you of the information we collect about you, how that information is used, whether and to whom we disclose it, and the choices you have regarding your personal information.

Collection and Use of Information

While using the VideoPodcasts.TV Service you may, among other things, gather information on our website, publish and download content, subscribe to one of our services. In doing so, we may collect certain information about you.

We may automatically collect certain aggregated data regarding use of the VideoPodcasts.TV Service, like the number of users and frequency and manner of usage of the VideoPodcasts.TV Service. We may also collect aggregated information regarding the use of our service network, such as the extent to which certain features are used. Aggregated information is anonymous, statistical information that reflects the scope of our user base, sales, customer patterns and related site information. We use this information to better understand how the VideoPodcasts.TV Service is used, and to improve the online experience of our users. This information is not used in a way that

will personally identify you. In addition, certain non-personally identifiable information is collected by VideoPodcasts.TV and our third-party advertising providers during the course of use of our Service and for example, in serving advertisements to our website, including, for example, the number of times you have viewed an advertisement (but not your name, address, or other personal information). Such information is used by VideoPodcasts.TV and our advertising providers to facilitate and monitor the serving of advertisements. Similarly, we may also use cookies to track and understand the traffic on our website. Cookies are alphanumeric identifiers that our website places onto your computer's hard drive. Cookies identify your computer hard drive so that we can recognize you the next time you visit us. We use cookies to collect and store some information about you, such as the name of the domain and host from which you access the Internet, the Internet Protocol (IP) address of the computer you are using, the date and time you access our website and the Internet address of the website from which you linked directly to our website. We use this information to better understand our users and customize our site for users' particular preferences. In the same manner, we may also engage third parties to monitor the usage of, and serve advertising to, the VideoPodcasts.TV Service. These third parties may use cookies and web beacons (which collect non-personally identifiable information regarding user behavior on our website) to collect such information, which is also used to better understand our users and customize our site for users' particular preferences. You may disable cookies by following directions on your web browser. Disabling cookies also disables web beacons. You should be aware, however, that by disabling cookies you may be unable to access certain services and features of the VideoPodcasts.TV Service.

We may collect personally identifiable information from you when you seek access to certain portions of the VideoPodcasts.TV Service, publish or download content, and/or register for our services. This information may include, but is not limited to, your name, physical and e-mail addresses, phone and/or fax numbers, Internet address, type of computer, as well as your preferences and usage patterns. This information may be used to fulfill your requests for services, to communicate with you about your account, to support your online activities, to respond to your questions, to customize your experience and to customize the content or features of the VideoPodcasts.TV Service. We may use your personally identifiable information to notify you of changes to the VideoPodcasts.TV Service, Terms of Use and/or Privacy Policy. We may also use your personally identifiable information to personalize your interactive experience on the VideoPodcasts.TV Service. For example, if you have given us permission, we may use your information to inform you of other products or services that you may find valuable. We may also use the information you provide to make improvements that better serve our users' needs. To edit your personal information that you entered when you created your account, you must log-in to VideoPodcasts.TV and click "my account" located at the top of any page to manage your account.

If you prefer not to receive information about additional products and services that we think you may be interested in, you can choose not to receive this information by opting-out when given the opportunity at the point we ask you for your contact information. You

may also choose to opt-out after the fact by following the Opt Out instructions provided below.

Disclosure of Information

We may share aggregated statistical information about users of the VideoPodcasts.TV Service with third-parties, including our distributors, vendors, actual and potential customers and third-parties that offer products or services for use with the VideoPodcasts.TV Service. This information is not linked to any personally identifiable information.

VideoPodcasts.TV will not share your personally identifiable information with any third-parties, with the following exceptions:

1. As necessary to third parties who perform services for us in operating and marketing the VideoPodcasts.TV Service, included but not limited to the monitoring of user behavior on our website and the processing of payments for products or services.
2. We may be obliged or deem it necessary or appropriate to disclose your information in certain special situations. These situations include: in response to legal process such as a court order or subpoena; to prevent or combat fraud; as required by federal or state law; enforcement of our Terms of Use; and protection of the rights, property or safety of VideoPodcasts.TV, our users or others.
3. We may disclose your information in connection with a merger, acquisition, or liquidation of our company and to parents, subsidiaries or affiliates of VideoPodcasts.TV.

Security

VideoPodcasts.TV is committed to taking appropriate measures to protect your privacy against unauthorized disclosures. VideoPodcasts.TV uses a variety of secure techniques designed to protect your information.
